"Countering exclusion and ensuring inclusive community structures"

The discussion is dedicated to the overarching question of how inclusive community structures are possible. Against the backdrop of a Europe-wide strengthening of right-wing populist and often equally anti-inclusive parties, which are also shaping public discourse in Germany, the question arises as to how this political trend affects the inclusive orientation of various areas of society. It will also discuss how a positive vision of an inclusive society can be brought into the public discourse and which political actors have key functions when it comes to creating and ensuring inclusive community structures.

The panel discussion will focus on the three levels of the region (state of Thuringia), the federal level and the European level. The focus will be on the following questions:

Where have we made noticeable progress in practice on the ground in recent years since 2008 in terms of implementing inclusive community structures?

- Why is it that only very little progress has been made in certain areas such as the school system?
- How can inclusion processes be made more dynamic?
- How can an image of inclusion be created that makes it clear that society as a whole would benefit from inclusive structures?
- Which institutions and political actors at federal and European level play a prominent role in implementing and ensuring inclusive structures?
- What are best-practice examples that illustrate that inclusive communities work and ensure participation?
- What can we learn from other European countries when it comes to achieving inclusive community structures?
- What can other European countries learn from Germany?

The associations of the International Society of Professional Heilpedagogic Organizations (IGhB) have been active for two decades and are challenged more than ever by social and political developments in the different member states and therefore in Europe as a whole. Heilpedagogues work with people in disadvantaged situations as well as people with disabilities of all ages and in different systems and fields of action. The framework conditions for the recipients of heilpedagogic actions as well as for the professionals are different throughout Europe — at the same time the various professional and specialist associations are united by the goal of supporting "politics and society in the context of inclusion, participation and the preservation/improvement of the quality of life of people in difficult life situations and their environment" (IGhB 2014:2).

THE STATEMENT

The statement is intended to look at the challenges in this field of European cooperation from the perspective of a person involved in European social policy.

Political developments in many EU member states no longer focus on successful social policy — the realization of an inclusive community must be continuously critically evaluated and actively demanded. Committed heilpedagogic work repeatedly and increasingly encounters economic and socio-political hurdles that require creativity and cooperation.

Solidarity beyond national interests and opportunities is essential. Mutual appreciation, openness and communication open up new paths.

Afterwards, they will discuss similarities and differences in a European context and reflect on social, societal and political developments against the background of heilpedagogic perspectives. The discussion will focus on the following questions, among others:

- What are the current challenges with regard to the goal of an inclusive community on a European level?
- What steps have already been taken towards an inclusive community? What are the similarities and differences between the various countries?
- What are the current perspectives in European politics regarding social policy, in particular for people with disabilities and for children, adolescents and families in disadvantaged situations?
- How does social and specific participation policy cooperation work at European level?
- Which actors at European or EU level are relevant with regard to heilpedagogic issues (participation, education in difficult circumstances, etc.)?
- In various European countries, extreme right-wing parties have become increasingly popular in recent years and some have been elected to government. Will the cooperation for an inclusive community change as a result?
